

LEGAL DESCRIPTION

119.20 ACRES

Part of the Southwest Quarter of Section 4, Township 14 North, Range 10 West, in the Third Principal Meridian, Morgan County, Illinois, more particularly described as follows:

Commencing at the Northwest corner of said Southwest Quarter of Section 4, Township 14 North, Range 10 West of the Third Principal Meridian; thence North 90°00'00" East, 2635.81 feet; thence South 00°16'25" East, 379.90 feet to the point of beginning on the South right of way line of Interstate 72; thence South 00°16'26"East, 2182.03 feet; thence North 89°52'36" West, 1984.83 feet; thence North 00°43'55" East, 116.88 feet; thence North 89°16'05" West, 150.00 feet; thence South 00°43'57" West, 118.41 feet; thence North 89°36'32" West, 219.99 feet; thence North 89°53'10" West, 204.66 feet to a point on the East right of way line of State Highway 267; thence North 00°37'58" West, 489.21 feet; thence North 05°36'42" West, 233.34 feet; thence North 00°32'19" East, 197.00 feet; thence South 89°27'41" East, 10.00 feet; thence North 06°06'07" East, 154.73 feet; thence North 06°17'39" East, 367.03 feet; thence North 00°00'12" West, 100.00 feet; thence North 53°14'58" East, on said South right of way line of Interstate 72, 93.60 feet; thence North 89°59'45" East, 40.00 feet to the beginning of a curve concave to the Northwest having a radius of 557.46 feet; thence Northeasterly on said curve left a chord bearing of North 64°54'29" East, a chord distance of 472.75 feet to the end of said curve; thence North 39°49'10" East, 239.41 feet to the beginning of a curve concave to the Southeast having a radius of 683.94 feet; thence Northeasterly on said curve right a chord bearing of North 64°21'23" East, a chord distance of 569.13 feet to the end of said curve; thence South 85°27'35" East, 644.40 feet; thence South 89°54'41" East, 656.79 feet to the point of beginning, containing 119.20 acres, more or less.
